In section 3, please provide information on your <u>undergraduate</u> degree (BSc or similar) and the University or institution at which it was granted. If you have obtained additional degrees, then you can provide information on these in section 4.

Please enclose with your signed application form the following documents:

- a. A scanned copy of your undergraduate degree certificate¹
- b. A translation of this certificate into English or Croatian, if necessary^{2,3}
- c. A scanned copy of your official list of grades or diploma supplement from your undergraduate degree¹
- d. A translation of the grade list into English or Croatian, if necessary^{2,3}
- e. A copy of your CV, written in English using Europass format
- f. Your personal letter of motivation, explaining why you wish to enrol in this program, written in English
- g. Two letters of reference, at least one of which should be from a member of faculty at the institution where you completed your undergraduate course. These should be written in English, and may either be supplied by the applicant or sent to us directly by the referees using the email address above

If your application is successful, then this form will also be used to apply for recognition of your previous degrees by the University of Rijeka. This is a requirement for enrolment for all applicants whose undergraduate degree was awarded by a University outside of Croatia⁴. In this case, we will also require the following from you. **YOU DO NOT NEED TO SEND THESE WITH YOUR INITIAL APPLICATION:**

- h. Copies of the official degree certificate and final grade list/diploma certificate, if not provided previously
- i. <u>Notary certified</u> translations of your undergraduate degree and grade list/diploma supplement into Croatian if necessary^{3,5} and if not provided previously
- j. If not detailed in the diploma supplement: official curricula (syllabus) of the undergraduate degree program, with short descriptions of the content of all courses, plus translation if necessary³
- k. If you have changed your name since graduation: A copy of your birth certificate, plus translation if necessary³
- I. Proof of your citizenship (or of refugee status) plus translation if necessary³







m. <u>For some students</u>⁶: Proof of payment of an administrative fee of 50.19 EUR⁷. This can also be deducted from your first tuition fee payment by arrangement.

Notes:

- 1) Applications may also be submitted if you are in the final year of your undergraduate studies. In this case, please instead supply a confirmation of your enrolment, and a list of grades for all years of study completed to date. In this case, any place on the course will be provisional on the applicant supplying proof of completion of the program and their final grades (transcript) by 23rd September 2024 (for undergraduate programs conducted in Croatia) or 31st August 2024 (programs conducted in any other country)
- 2) For the initial application procedure, an unofficial translation will suffice. If you are accepted for the course, then a notary certified translation will be required, see item (i).
- 3) Documents written in English, Croatian, Bosnian or Serbian (Latin alphabet) do <u>not</u> need to be translated.
- 4) Applicants who completed their undergraduate degree at a University within the Republic of Croatia do not need to undergo this procedure.
- 5) A translation into English may be provided instead, if translation services into Croatian from your language are not easily available.
- 6) Courses from some Universities are automatically recognised, and a fee is not required. At time of writing, we cannot confirm which Universities this will apply to, so please contact us at this stage to find out if the fee is required or not.
- 7) This is equivalent to 400 HRK (Croatian kuna). The EUR (euro) was introduced as the official currency in the Republic of Croatia on 1st January 2023, although many prices are still given in both currencies. There is an established fixed exchange rate of HRK 7.53450 for 1 EUR. All payments relating to students starting in 2024 will therefore be made in EUR.
